STUDIO Y GYMNASTICS

CLASS DESCRIPTIONS

TINY TUMBLERS 1

This class is for our beginner students, typically 4-5 year olds. We will work on following directions and taking turns, in addition to tumbling skills such as: flexibility, somersaults, cartwheels, jumps, headstands, and bridges.

LEVEL 1

Level 1 is for students under 7 who have passed tiny tumbler skills. In order to take Level 1, each child must have mastered a cartwheel. In this class, we will work on flexibility, tumbling passes, limbers, and handstands.

LEVEL 2

Level 2 is for students 7 and up, who have passed tiny tumbler skills. In order to take Level 2, each child must have mastered a cartwheel and have a strong bridge/twist out and handstand. In this class, we will work on flexibility, tumbling passes, limbers, and handstands. This class will have very light bar and beam work.

LEVEL 3

Level 3 is for students who have passed Level 1 and 2. In order to take Level 3, each child must have mastered a cartwheel, backbend and up, and a front limber. In this class we will work on limbers, walkovers, front/back handsprings, and aerials. This class will have VERY light bar and beam work, as we want a heavy focus on mastering tumbling skills.

LEVEL 4/5

Level 4/5 is for students who have mastered level 3 skills (front/back limbers, walkovers, and front handsprings) and are ready to focus on back handsprings, back tucks, aerials, and other advanced skills.

Returning students should enroll in the class specified on their progress report from the end of the 2022-2023 season. Any new students enrolling in Levels 1-5, please contact Kelsie Boyer, Gymnastics Head Instructor at kboyer@spencerymca.org before enrolling so we can ensure they are enrolling in the correct class.

 (initial) For my benefit and convenience, I hereby request and authorize the Spencer Family YMCA to charge my account an automatic bank withdrawal payable to the Spencer Family YMCA to its own order. This authorization, including yearly Dance Class rate increases or deductions will remain in effect until revoked by me in writing, and until you actually receive such notice. I agree that the Spencer Family YMCA shall be fully protected in honoring any such withdrawal. STUDIO Y CLASS balances must be paid in full before this agreement can be cancelled or terminated.

 (initial) In consideration of your compliance with such request and authorization, I agree that the YMCA's treatment of each such withdrawal, and YMCA's rights in respect to it shall be the same as if it were signed personally by me and that if any such withdrawal be dishonored, whether with or without cause, the YMCA is secure under no liability whatsoever even though such dishonor results in the forfeiture of membership. Each dishonored or returned bank draft will have a \$25.00 return service fee.
